### PROFESSION AND PROFESSIONALISM What Do These Words Mean For Lawyers?

Law is a profession. As lawyers in Alabama, we are governed by the Alabama Rules of Professional Conduct. I have been musing about the meaning of the terms "profession" and "professionalism." The classic definition of a profession is an occupation based on a specialized body of knowledge and skills, entry into which is restricted to those who prove their competence, conducted in the interest of those it serves and of the public generally, and subject to self-imposed rules of ethical conduct. Professionalism is a more difficult concept to define. One writer suggested that the lack of a definition of professionalism suggests lawyers take Justice Potter's 'I know it when I see it' approach to defining pornography. Many writers agree that the ethical rules that govern lawyers are the minimum standard and professionalism is the higher standard expected of all lawyers. Let us consider each element of the definition of a profession and think about how we can go beyond the minimum and reach that higher level of true professionalism.

A profession involves a specialized body of knowledge and entry into the profession is restricted to those who prove their competence. We do not, however, finish acquiring legal knowledge when we pass the Bar exam. Not only are we to complete our CLE every year but to be truly professional, we should do so gladly. If you are like me, you have groused about this requirement on occasion; however, most lawyers are intellectually curious folks by nature and enjoy learning the latest legal trends and developments.

A profession is conducted in the interest of those it serves and of the public generally. This element seems obvious on its face but, in the busy and demanding practice of law, there are times when we all can all benefit by taking a deep breath and carefully evaluating our actions through this lens. As lawyers, we are to elevate our clients' concerns above our own. We are to consider our actions in the broader context of a client's particular matter, the administration of justice, and how our conduct reflects on the legal field as a whole. That our conduct reflects on the administration of justice and on the entire legal field should affect all areas of our work from strategy to procedure to advertising. We should also bear in mind that excellent customer service is the hallmark of all true professionals and good communication is one of the best ways to ensure a satisfied client.

## REPORT OF DIVERSITY & INCLUSION COMMITTEE BLACK HISTORY MONTH

Black History Month first originated as part of an initiative by writer and educator **DR. CARTER G. WOODSON,** who launched Negro History Week in 1926. Woodson proclaimed that Negro History Week should always occur in the second week of February — between the birthdays of **FREDERICK DOUGLASS** and **ABRAHAM LINCOLN.** Since 1976, every American president has proclaimed February as **BLACK HISTORY MONTH.** Today, other countries such as Canada and the United Kingdom also devote an entire month to celebrating Black history. The intention has never been to dictate or limit the exploration of the Black experience, but to bring to the public's attention important developments that merit emphasis.

The theme for Black History Month in 2018 is "AFRICAN AMERICANS IN TIMES OF WAR" honoring those brave men and women who served their countries in the armed forces, especially those who made the ultimate sacrifice while defending the American ideals of freedom and democracy. During World War II, for example, more than 2.5 million black men registered for the draft and one million served as draftees or volunteers in every branch of the armed forces.

Even so, more than 12,000 black men who served in the segregated 92nd Division received citations or were decorated for "extraordinary heroism" on the battlefield. Perhaps more famously, the **TUSKEGEE AIRMEN** also became legendary for their heroic feats, and in total received a **DISTINGUISHED UNIT CITATION**, several silver stars, 150 distinguished flying crosses, fourteen bronze stars, and 744 air medals.

In 1776 and 1777, a dozen African American Marines served in the American Revolutionary War, but from 1798 to 1942, the United States Marine Corps (USMC) followed a racially discriminatory policy of denying African Americans the opportunity to serve in the Marines. For more than 140 years, the Marines recruited primarily European Americans and white Hispanics, along with a few Asian Americans. The USMC opened its doors to blacks in June 1942, with the acceptance of African Americans as recruits in segregated all-black units. For the next few decades, the incorporation of black troops was not widely accepted within the Corps, nor was desegregation smoothly or quickly achieved. On February 23, 1979, **FRANK E. PETERSEN**, the first African American aviator in the USMC, promoted to brigadier general, becoming the first African American general in the Marine Corp. He ultimately promoted to lieutenant general on June 12, 1986. By 2006, approximately 20% of the USMC was African American.
